2. That said Contractual Obligations are substantially in the form, and have been duly executed and signed in the manner, prescribed in the order authorizing the issuance of said Contractual Obligations.

3. That at the time we so executed and signed said Contractual Obligations we were, and at the time of executing this certificate we are, the duly chosen, qualified and acting officers indicated therein, and herein, and authorized to execute same.

4. That neither the corporate existence nor boundaries of said District are being contested; that no litigation has been filed or is now pending which would affect the authority of the officers of the District to issue, execute, and deliver said Contractual Obligations; and that no authority or proceedings for the issuance of said Contractual Obligations have been repealed, revoked, or rescinded.

5. That we have caused the official seal of the District to be impressed, or printed, or lithographed on each of said Contractual Obligations, and said seal on said Contractual Obligations has been duly adopted as, and is hereby declared to be, the official seal of said District.

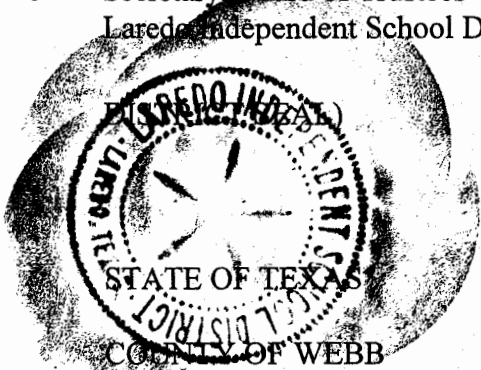

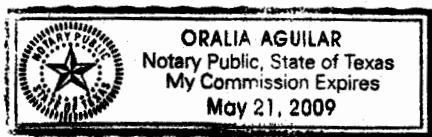
